The client of the service desires to employ Nick Werner to provide entertainment and coordinate sound activities for one engagement. Nick to accomplish the services requested under this agreement, it is hereby agreed by and between the client and Nick Werner as follow:

1. Nick Werner agrees to provide to the client for compensation entertainment service which may include a professional sound system, continuous music, light show and a master of ceremonies to coordinate these entertainment and social activities.
2. The client, in consideration for these services, agrees to pay Nick Werner, the deposit with the return of this agreement and the balance on or before the date of the event.
3. The client or Nick Werner has a right to cancel this agreement, in writing, 14 days or more prior to event date. Should Nick Werner cancel, a full refund of deposit will be returned.
4. Liability of Nick Werner shall not exceed total cost of DJ services.
5. Client shall at all times have the complete supervision and control over the guest, employees, and any other persons attending the event, and fully assumes full responsibility for their actions with regard to any personal injury, equipment damage(s) sustained by Nick Werner.

6. During outside events, Nick Werner is not responsible for weather. In the event of rain or threatening weather conditions, adequate shelter is the responsibility of client and must be provided before set-up of equipment.

7. Nick Werner has the right to replace himself with another professional DJ, if an emergency or illness accrues, without written notice.

8. The client agrees that as a condition precedents to the performance of the terms of this agreement Nick Werner, he will have prior to the time of the event, secure the facilities for the event as well as any stamps, licenses, authorizations and permits that are necessary and proper to allow Nick Werner to execute the terms of this agreement.

9. Balance due date and late fee. The client agrees that he will pay to Nick Werner the balance due on the date stated. Should the client fail to pay for the service agreed to, Nick Werner will NOT perform any entertainment on the event date.
